INTRODUCTION:

The Zeitz Family Papers came to the New Bedford Whaling Museum Library from the Waterfront Area Historic League, (WHALE) after they had obtained jurisdiction over the former State Theatre on Purchase Street in New Bedford, MA in the 1980's.

After the library accessioned the collection the papers were surveyed and loosely arranged. They appear to have been papers and items left at the theatre and not in the direct possession of family members. The final arrangement is based upon the arrangement created in the initial survey.

This is a diverse collection of personal papers and photographs, and legal and business papers relating to the numerous properties and theatres owned by the Zeitz family. Although there is little in the way of personal correspondence, there are numerous handwritten notes.

BIOGRAPHICAL NOTES:

Kopel (1860-1904) and **Fanny (Genesky) Zeitz (1860-1930)** were married in 1880. In 1883 they immigrated from Russia to the United States. They appear to have lived for a time in Texas and New York City before arriving in New Bedford. The family business is listed in 1900 as the New Bedford Bottling Co. located at 32 Morton Court in New Bedford, MA.

Their children were:

Phillip (1881-1910) He was born in Russia and listed as a machinist in New Bedford in 1903. In 1908 he married **Etta Wischmersky**.

Barney (1882, 1883 or 1887 -1946) He claimed to have been born in "the middle of the Atlantic" but has been listed as being born in Russia as well as New York City. He owned and operated the Barney Zeitz Hardware Store (also Zeitz & Grimshaw Hardware) at 90 Union St. in New Bedford. Barney Zeitz was also occupied in pawn broking, money lending and other enterprises but was most well known for the salvaging of a ship off Martha's Vineyard. By 1930 he is listed as a proprietor of theatres. He never married.

Myers (Charles?) 1886-1926) He may have been born in Fall River. He was listed in the census as a commercial traveler in 1911. He enlisted in the medical detachment at Raritan Arsenal during WWI as Charles Coleman.

Jacob Frank (1888-1953) He was either born in Texas or New York City. He was listed as a chauffeur at the family owned New Bedford Bottling Co. He was associated with his brothers in the family business. He was married to Ann Zeitz.

Harry (1889-1971) He is listed as being born in Massachusetts (New Bedford?). He was listed as a pawnbroker in 1915 at 94 Union St. New Bedford. He married Cecile I. Bornstein (1898-1978). They had a son Robert Merrill (1929-1973). They lived at 37 Taber Street, New Bedford in 1932. After Barney's death in 1926 he appears to have become the dominant figure in the family enterprises.

Isaac Morton (1890, 1895-1973,1979?) He is listed as being born in Massachusetts (New Bedford?). He is listed as a salesman in 1911. He was a major figure in the family businesses.

Phillip (Fisher?) (1895-1959)

Etta (Anna) Zeitz Helford (1898-?) She married George Helford, an attorney in New Bedford. They had a daughter, Ruby Helford Aronsky. (1924?-2012)

Elaine Zeitz Anderson (1923-?) Married Lawrence M. Anderson. They had a son Frederick (1945-?)

Carl (1921-1973) Married June Jaffe. He served in the Army Air Corps - Bombardiers Class 44-13, 1944

The Zeitz family owned and operated the following businesses and theatres:

Barney Zeitz Hardware, Zeitz and Grimshaw, Zeitz Realty Corp., Ho-Zi Inc., ABC Vending Corp., Herschel Amusement Co. Inc., Haverhill Operating Co., New Bedford Amusement Co., Zeitz Theatre of Rhode Island (Newport), Zeitz Theatres of Fall River, Inc., The Paramount Theatre in Haverhill, and the Academy Theatre, Fall River. In addition they owned the Civic Theatre in Portland, Maine. In New Bedford they owned the State Theatre, later the Zeiterion, the Olympia Theatre, the Empire Theatre, and the Capitol Theatre.

The Zeitz Realty Corp. (ZRC) held the following properties in New Bedford at various times.
